

The following policy, is applicable to Location Locketgo's Inc. ("Locketgo" or "We") information collecting use and disclosure practices for Locketgo's Website, mobile application or social media pages and accounts that are available on computer, mobile phone or any other electronic device (together , the "Sites") and Locketgo's locker rental services (the "Services"). For the purposes of this Agreement, "Website" means locketgo.com or any other website or application through which Locketgo makes its Services available and posts this policy.

Your use of the Sites and Services tells us you have read and accept the practices outlined in this policy. This privacy policy applies to personal information that we may obtain from you, how we use it and under what circumstances we can disclose it. This policy does not apply to the practices of third parties that Locketgo does not own or control or to people it does not employ or manage.

PERSONAL INFORMATION COLLECTED

In this Privacy Policy, "personal information" means information or pieces of information that could allow you to be identified. We ask and collect your personal information in several ways, including, but not limited to, when you:

- Browse our Sites;
- Create an Account on our Sites;
- Reserve a Locker through our Sites or at the Event;
- Submit a comment or a question via our Sites, by email or by any other means of communication;
- Report a lost item via our Sites, by email or by any other means of communication;
- Consent to receive marketing communications via email or SMS messages;
- Respond to a survey or participate to a contest or other features of our Sites and Services, or respond to offers or advertisements;
- Post on our social media accounts;
- Apply for a job.

On each of these occasions, you may provide personal information such as, but not limited to, your first name, last name, email and postal address, phone number, date of birth, credit card details and the name of the Event you want to attend. In certain cases, we may also collect additional informations such as your IP address, your preferences and and interests.

Account creation through social networking sites. When available, you may create an Account by using your social network credentials. When connecting your Account with any of your social network account, you hereby acknowledge that we may collect personal information you have made available on those social networking sites, such as your name, username, gender, age, date of birth, profile pictures, friend list and any other information you have made public, and you hereby consent to the continuous release of information about you to us. Our collection of personal information from these social networking sites remains subject to the privacy settings you may have set within these social networking sites, as well as the policies set by such sites and applicable to our collect of information.

Payment Information. When you make a financial transaction with Locketgo, you may have to provide, in addition to your name and email, your billing address and telephone number in order to confirm your order and comply with applicable law. When we use the services of third party payment processors, we will not collect nor store any of your payment information (such as bank account or credit card information). Collection and use of your payment information are then subject to those third-party payment processor's privacy policies.

Marketing Communications. When you request to receive promotional communications via email or SMS messages, we may collect personal information such as your first name, last name, email address, phone number and interests in order to provide you with the service you requested.

We will not contact you for promotional purposes, unless you specifically agree to be contacted for such purposes. Locketgo reserves the right to stop sending marketing communication at any time. You have the option to opt-out of our marketing communications by following the instructions for unsubscribing included in our marketing communications, by changing your notification settings within your Locketgo Account, when applicable, or by contacting Locketgo at info@locketgo.com. Please note that even if you opt-out of promotional communications, we may still need to contact you with important information about your Account or the Sites and the Services.

Comment, Question and Lost Item. When you comment, ask a question, report a lost item or otherwise contact us via our Sites, email or any other means of communication, we may collect personal information such as your first name, last name, email address, phone number, name of the Event which you attended and the date of the event. Also, by posting or contacting us on our social media accounts, we may collect your personal information you have made publicly available on the social networking site, such as your name, profile picture, cover photo, username, gender, friends network, age range, location, friend list and any other information you have made public.

Survey, Contest, Offer. When you respond to a survey, participate to a contest or respond to offers or advertisements, we may collect personal information such as your first name, last name, address, phone number, email address and interests. We use this information to administer your participation in the contest or offer and, for surveys, to understand our customers and enhance our product and service offerings, promotions and events. At the time you are entering the survey, offer or contest, we may ask your permission to send you future marketing communications.

Job Application. When you apply to work with us through our Sites, we will use your personal information to process your application and to monitor recruitment statistics. We may also use third parties to assist us in our recruitment process, which may have access to your personal information.

Log Data. We automatically receive information when you view or engage with our Sites and Services, such as the type, duration and content of your activities on our Sites, which we refer to as "Log Data", even if you have not created an Account with Locketgo. We use Log Data to operate and optimize our Sites and Services. For example, we review Log Data to determine what content is popular on our Sites. We receive information, such as your IP address, country and city associated with your IP address, information about your browser, device-specific information. We may use IP addresses to analyze trends, administer the Sites, track users' movements and gather broad demographic for aggregate use. In order to operate our Sites and Services, we keep track of how you interact with links across our platform. This may include links on our Sites, emails, and social media accounts (Facebook, Twitter, LinkedIn).

USE OF YOUR PERSONAL INFORMATION

Locketgo is the sole owner of the information collected on its Sites or through the Services. We will not sell, share, or rent this information to others in ways that vary from what is disclosed in this policy. We collect, store, and process information, including personal and non-personal information, in variety of ways in operating our business, mainly:

- to allow us to provide our Services;
- to analyze your usage trends and preferences;
- to improve our Sites and Services;
- to detect, prevent and address security issues;
- to answer questions and information requests;
- for the purposes of marketing, advertising or contests;
- for any other purposes authorized or required by law.

We only collect necessary information for the purposes that are identified in this policy and for legitimate business reasons. We will not use personal information obtained for a particular purpose for anything else without informing you first and obtaining your express consent, when required.

We, however, reserve the right to disclose personally identifiable information as required by law and when we believe that disclosure is necessary to protect our personnel, rights or property, or for safety reasons, and/or to comply with a judicial proceeding, court order or legal process served on us, or to respond to a government or other administrative request. We further reserve the right to disclose personally identifiable information in the context of the sale of all or part of our assets, whether on a voluntary basis or through bankruptcy.

INFORMATION SHARING

It is often necessary to use the services of third parties for the purposes of providing our own Sites or Services to you. For example, third parties to whom we may share your personal information may assist us with the billing, customer service, hosting and analytics. We may need to share your information with them for these purposes. When we disclose your personal information to third parties, we take reasonable measures to ensure that the rules set forth in this Privacy Policy are complied with. These third parties will obtain only the personal information that are necessary for the purpose for which Locketgo has employed them.

At any time, we may disclose to third parties non-personal data, such as aggregated information like the total number of times people who visited a given page on our Sites.

COOKIE POLICY

Our Sites, like most other commercial websites, also uses cookies. These are files that are installed on your computer hard drive or web browser in order to collect information such as your language of preference, browsing history and browser type and version, all for the purpose of optimizing your experience on our Sites. These cookies cannot be used to extract personal information. However, we can match the information collected by cookies with other information through the Sites.

We use required cookies, that ensure that the Sites functions properly and enable you to access the full functionality of our Sites and Services. We also use other cookies, such as analytical or social media cookies. You can manage your cookies settings through your browser, but disabling cookies on your browser could adversely affect your browsing experience on the Sites.

We sometimes embed content from some third parties such as social media plugin (e.g. “share” or “like” buttons), all of which may use cookies on their website. However, the use of these cookies is not covered by this Privacy Policy and we have no access to or control over these cookies.

THIRD-PARTY LINKS

Our Sites may contain links to other websites. Please be aware that Locketgo is not responsible for the privacy practices of such other websites. We encourage our users to be aware when they leave our Sites and to read the privacy statements of each and every website that collects personally identifiable information. This privacy statement applies solely to information collected by our Sites and Services.

CHILDREN AND OUR SERVICES

Locketgo's Services are not directed to children, and you may not use our Services if you don't have the capacity to enter into this Agreement under the applicable laws in your country of residence. You must also be old enough to consent to the processing of your personal data in your country (in some countries we may allow your parent or guardian to do so on your behalf). We do not knowingly collect personal information from children under 13 or under the applicable age limit in your jurisdiction for giving consent to the processing of personal data. If you are a parent of a child under the age limit and become aware that your child has provided personal information to us, please contact us at info@locketgo.com and you may request exercise of your applicable access, rectification, cancellation, and/or objection rights.

YOUR RIGHTS

You may exercise any of your rights by sending an email to info@locketgo.com. Please note that we may ask you to verify your identity before taking further action on your request. Your rights in

connection with your personal information may be different according to the applicable regulations on the protection of personal data in your province or state of residence.

On written request and subject to proof of identity, you may consult the personal information that we have disclosed, and ask that any necessary corrections be made, where applicable, as authorized or required by law. To make sure that the personal information we maintain about you is accurate and up to date, please inform us immediately of any change in your personal information at info@locketgo.com. In some jurisdictions, applicable law may also entitle you to request copies of your personal information held by us. You may also be entitled to request copies of personal information that you have provided to us in a structured, commonly used, and machine-readable format and/or request us to transmit this information to another service provider (where technically feasible).

CONSERVATION PERIOD

We store data pertaining to you only for the period required to accomplish the purposes for which they are processed or until your Account is deleted, unless further recording is permitted or requested by applicable law, or unless we have to keep it for legitimate business or legal reasons. This is a case-by-case determination that depends on factors such as the nature of the data, why and how it was collected and processed, and relevant legal or operational retention needs.

SECURITY

We take reasonable precautions to protect the privacy, accuracy, and reliability of any information you provide to us and we use adequate technical and organizational safety measures in order to protect your information from loss, misuse, destruction, unauthorized access, copy or alteration. We have also implemented physical and organizational safeguards in accordance with which only employees who need the information to perform a specific job are granted access to personally identifiable information. However, while we endeavor to use security measures consistent with industry standards and reasonable efforts to safeguard the confidentiality of your information, we cannot guarantee that information provided to us will not be intercepted and remain secure. Therefore, you transmit any information to or from the Sites and Services at your own risk. Locketgo does not represent, warrant or guarantee that personal information will be protected against loss, misuse or alteration and does not accept any liability for personal information submitted by you, nor for your or third parties' use or misuse of personal information.

MODIFICATIONS

This Privacy Policy may be amended from time to time, due to the development of our Sites and Services, or for legal matters. When modifying our Privacy Policy, we will make commercially reasonable efforts to advertise such modification on our Sites. Your continued use of the Sites and the Services after any such change constitutes your acceptance of this Privacy Policy, as revised.
